TORONTO CITY COUNCIL APPROVES NEW TAXI BYLAW

On Wednesday, June 11, 2014, Toronto City Council passed the controversial bylaw that will change the face of the taxi industry for years to come.

After three years of deliberation, debate and delay, Council voted 31-12 in favour of significant changes that will affect both passengers and everyone else involved in the industry.

The vote created a new kind of taxi licence, the Toronto Taxicab Licence (TTL), which all plate owners must obtain by 2024. Everyone with a TTL will have to use a wheelchair-accessible vehicle. That means the city's entire taxi fleet will be accessible within 10 years.

The Toronto Taxi Alliance, the industry group composed of taxi owners and taxi fleet operators filed an application for an interim court injunction to "quash" the recently approved City Taxi Bylaw.

On Wednesday, June 25th, the Ontario Superior Court of Justice ordered that the City of Toronto is hereby enjoined (forbidden) from acting upon or implementing those sections of the new Bylaw (503-2014) that apply to Standard Taxicab Licence holders until the final adjudication of the Application by the Superior Court of Justice so as to permit the issuance of a Standard Taxicab Licence to the purchaser upon the sale of the standard taxicab.

The Court further ordered that in the event the Bylaw is upheld by the Superior Court of Justice, no rights are conferred (awarded) by this order that would entitle a party who acquires a Standard Taxicab Licence after June 30th, 2014, to be treated as if they had been a Standard Taxicab Licence holder prior to July 1, 2014.

The Court upheld all aspects of the new City of Toronto Bylaw with the exception of the Standard Taxicab Licence as stated above.

The matter will be heard in full before the Superior Court of Justice in the Fall of 2014.

Municipal Code Chapter 545 – New Bylaw Highlights

The Toronto Taxi Licence (TTL):

- Must be driven by its owner (167 hours/month)
- · Can be rented out to other drivers
- Requires a wheelchair accessible vehicle that is D409 compliant
- · Must be associated with a licensed brokerage
- Is transferable, which means that the taxicab can be sold after two (2) years
- Up to 290 TTLs will be issued to drivers on the waiting list
- Election letters will be sent to drivers on the waiting list starting in June 2014 by order of seniority
- TTLs will also be issued to purchasers of Standard, Ambassador or TTL taxicabs after July 1, 2014
- Existing taxicab drivers who would like to drive the TTL taxicab on a shift basis, must complete an accessible course (unless you already have an accessible endorsement)
- All new taxicab drivers will be trained to drive on TTL taxicabs

Additional Bylaw changes:

- The new Taxicab Bill of Rights combines the rights of passengers with the rights of drivers
- Drivers can charge a \$25 cleaning fee if a passenger soils the taxicab
- Drivers can request payment of fare in advance, to a maximum of \$25
- Taxicabs are required to have snow tires from December 1 to March 15
- Review of leasing and designated agents (to begin in 2015)
- City of Toronto is creating a working group to research: dedicated vehicle; vehicle information technology passenger information monitors; credit and debit terminal;

The Accessibility for Ontarians with Disabilities Act, 2005 (A.O.D.A.) requires employers in the province to establish a program in support of customer service delivery to those with disabilities. While A.T.T.C.L. has always strived to provide customer service excellence, it welcomed the opportunity to formalize its customer service commitments.

This program consists of three-parts. First a formal declaration as outlined in A.T.T.C.L.'s A.O.D.A. Customer Service Standard in which is described our service commitment and an invitation for feedback to verify the program's effectiveness. The second part is the establishment of a Workplace Coordinator position. Barbara Whitehurst, who has assumed the role, will be instrumental in monitoring the program for its effectiveness. She is available to those wishing to provide feedback on the program. The program's third part is the extensive training provided to all A.T.T.C.L. staff as well as new drivers. The training includes an in-depth review of the A.T.T.C.L. A.O.D.A. Customer Service Standard and its application to service delivery.
